RESOLUTION NO. 2023-27

RESOLUTION CLARIFYING ORDINANCE 10-2023,
COMMITTING TO CERTAIN ROAD MAINTENANCE

Whereas, Kirby Brothers, LLC, the sole owner of three parcels, being Stark County tax parcels 1000479, 1001611, and 1003803, located at and adjacent to 6500 Blough Road SW, and constituting 33.4816 acres, more or less, has petitioned for their annexation into the Village of Navarre under Ohio Revised Code, Sec. 709.023, and

Whereas, the Stark County Auditor website currently lists the above three annexation parcels as containing 35.45 acres, more or less, which number is contained within Navarre Ordinance 10-2023, stating which services the Village will provide to the annexation territory, and

Whereas, after annexation, approximately 1,240 lineal feet of Blough Road will separate annexed territory from unannexed Bethlehem Township territory,

Now Therefore, Village Council Resolves as follows –


(1) It is clarified that the annexation parcels referred to in Ordinance 10-2023 and in the annexation petition are the very same parcels, those being described in the annexation map and known as Stark County tax parcels 1000479, 1001611, and 1003803.

(2) The Village commits to Bethlehem Township that, upon annexation, the Village will thereafter be responsible for maintenance of both sides of the entire 1,240 lineal feet of Blough Road that will separate the annexed territory from unannexed Bethlehem Township territory.

(3) This Resolution is passed with only one reading, as it is required to be passed within a limited time after the filing of the annexation petition with the Board of County Commissioners, to clarify the composition of the annexation territory and the Village's commitment to road maintenance.
