RESOLUTION NO. 2023-31

RESOLUTION AUTHORIZING ENTERING INTO CONVEYANCE
OF SEWER SERVICE RIGHTS ON BLOUGH AVENUE, AND TO
PAY STARK COUNTY FOR SAME

Whereas, the Village of Navarre is in the process of annexing certain territory on Blough Ave. SW, including 6500 Blough Ave. SW, and Stark County tax parcel 1001611, and

Whereas, the Board of County Commissioners approved annexation of that (and other) territory on September 13, 2023, and Village Council intends to accept said annexation, and

Whereas, part of the consideration for the annexation was for the applicant/owner to be able to construct a private sewer system to tie into Navarre's wastewater treatment plant, and

Whereas, the sewer servicing rights to parcel 1001611 belong to the Stark County Sanitary Engineer, and must be conveyed to the Village, for the sum of \$5,047.37, subject to a potential small upward or downward adjustment, payable to the Stark County Board of Commissioner,


Now Therefore, Village Council Resolves as follows –

(1) The Fiscal Officer and Village Administrator are authorized and directed to pay the Stark County Board of Commissioners, c/o Stark County Sanitary Engineer the sum of \$5,047.37 to acquire the sewer servicing rights to parcel 1001611 (65 Blough Ave. SW).

(2) This Resolution is passed with only one reading, as time is of the essence for the applicant to construct the private sewer system during good weather.


