RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS
DETERMINED BY THE STARK COUNTY BUDGET
COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES
AND CERTIFYING THEM TO THE COUNTY AUDITOR

WHEREAS, on October 16, 2023, Village Council met in public regular session, at Village Hall, with all five of six members of Council present, and

WHEREAS, the Stark County Budget Commission has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by Village Council, and what part thereof is without, and what part within, the ten mill limitation,

NOW THEREFORE BE IT RESOLVED by Village Council that:

SECTION 1: Village Council accepts the amounts and rates as determined by the Budget Commission in its certification.


SECTION 2: There is hereby levied on the tax duplicate of the Village of Navarre the rate of each tax necessary to be levied within and without the ten mill limitation, as set forth in Schedules A and B attached hereto.

SECTION 3: The Village Fiscal Officer is directed to certify a copy of this Resolution, with its attachments, to the Stark County Auditor.

SECTION 4: This Resolution is deemed an emergency, as the Tuscarawas County Auditor requires passage and forwarding of this Resolution on or before October 31, 2023.
