RESOLUTION DIRECTING FISCAL OFFICER  
TO PROVIDE NEW ADDRESS TO PARCEL WITHIN VILLAGE

Whereas, on or about July 1, 2022, Kristina Miller purchased Stark County tax parcel 10013841, which listed the parcel address on the deed as 50 Sisterhen Court NW, Navarre, Ohio 44662 (though it should have been numbered 50 Sisterhen Court SW), which parcel is immediately behind Village Hall on Sisterhen Court, and

Whereas, the Stark County Auditor has given the parcel an address of 36 Ohio Street SW, even though the parcel does not front onto Ohio Street, and even though another parcel (parcel 10013842) that parcel 10013841 is behind also has an Auditor's address of 36 Ohio Street SW, and

Whereas, the post office uses the Auditor's address for parcel 10013841, that being 36 Ohio Street SW, with the consequence that mail delivered to parcel 10013841 ends up in the mailbox associated with parcel 10013842,

Now Therefore, Village Council Resolves as follows –


To correct the foregoing situation, the Fiscal Officer is directed to renumber tax parcel as 50 Sisterhen Court SW, Navarre, Ohio 44662, on the Village's address records, and to furnish a certified copy of this Resolution to the Stark County Auditor (map office), with a request that the new address be given to parcel 10013841 on the Auditor's records; and to furnish a certified copy of this Resolution to Kristina Miller that she can provide to the post office.
