RESOLUTION NO. 2023-4A

A RESOLUTION AUTHORIZING SECOND OF TEN ANNUAL TAX
COMPENSATION PAYMENTS TO BE MADE TO PERRY AND FAIRLESS
LOCAL SCHOOL DISTRICTS RELATED TO TAX ABATEMENTS
GRANTED TO HENDRICKSON, U.S.A., LLC

Whereas, on April 8, 2019, the Village of Navarre approved an Ohio Enterprise Zone Agreement, benefitting Hendrickson U. S. A., LLC and Navarre Facility, LLC ("Hendrickson" and "Navarre Facility"), which included a sixty percent (60 %) property tax abatement for the tax years 2021-2030 (payable in 2022-2031), and

Whereas, to comply with Ohio Revised Code, Sec. 5709.82, Village Council enacted a tax compensation formula in Ordinance 17-2019, as amended in Ordinance 29-2020, providing for tax sharing payments for a ten year period to Perry Local School District, and

Whereas, Hendrickson with-held and paid \$61,111.05 to the Village of Navarre in 2021, and Navarre Facility made no such payments to the Village of Navarre in 2021, and

Whereas, under the tax compensation formula in Ordinance 17-2019, Perry Local School District was paid \$17,023.81 for the 2021 year's tax sharing payment, and

Whereas, Hendrickson with-held and paid \$72,853.79 to the Village of Navarre in the first three quarters of 2022 and Navarre Facility made no such payments to the Village of Navarre in 2022, and

Whereas, under the tax compensation formula in Ordinance 17-2019, Village Council authorized payment to Perry Local School District of \$20,294.98 for 2022 year tax sharing payment, and

Whereas, said payment has not yet been made, as Village Council was advised that the aforesaid 2022 tax receipts did not include the fourth quarter payment, and

Whereas, it is now known that Hendrickson with-held and paid \$101,367.87 to the Village of Navarre for all four quarters of 2022, and that under the tax compensation formula in Ordinance 17-2019, Perry Local School District is actually entitled to \$28,238.19,

Now Therefore, Village Council Resolves as follows –

That Resolution 2023-4 is amended, and the Village Fiscal Officer shall pay Perry Local School District the sum of \$28,238.19 for the year 2022, being the second of ten annual payments due to Perry Local School District.

Passed with sufficient votes from Village Council to avoid a three reading requirement.
