RESOLUTION AUTHORIZING VILLAGE ADMINISTRATOR AND MAYOR
TO RE-AUTHORIZE PARTICIPATION AS A
PUCO CERTIFIED ELECTRIC AGGREGATOR

Whereas, the Village of Navarre currently participates in an electric aggregation program for the benefit of its residents, and the supplier currently is Constellation NewEnergy, Inc, and

Whereas, the State of Ohio Public Utilities Commission requires bi-annual re-certification of the Village's participation in an electric aggregation program, and

Whereas, the Village has continuously participated in an electric aggregation program, pursuant to Ordinance 2-2003, and

Whereas, with the assistance of Buckeye Energy Brokers, has determined that it is in the best interest of the retail electric users within the Village corporation limits to renew the PUCO electric certificate for an additional two-year period, August 9, 2023 to August 9, 2025.

The Village of Navarre has an interest in seeing that its residents receive uninterrupted electric service,


Now Therefore, Village Council Resolves as follows –

That the Village of Navarre, through its Mayor and/or Village Administrator may execute the PUCO Competitive Retail Electric Service Governmental Aggregator Application.

This Resolution is deemed an emergency by Council, as time is of the essence to prevent interruption of electric service to the Village's residents, and to procure a favorable electric price structure in a period of extremely volatile energy pricing.


