RESOLUTION AUTHORIZING MAYOR AND VILLAGE
ADMINISTRATOR TO SUBMIT GRANT APPLICATION
TO OHIO DEPARTMENT OF NATURAL RESOURCES UNDER

Whereas, the State of Ohio through Ohio Department of Natural Resources is accepting grant applications through June 1, 2024 to financially assist communities with provision for public recreation purposes under the Ohio Natureworks Grant Program, and

Whereas, the Village of Navarre needs and desires financial assistance to repurpose part of its Underwood Park for pickleball, which will be a substantial public recreation benefit for the community,

Now Therefore, Navarre Village Council Resolves as follows:

The Mayor or Village Administrator are authorized to submit forthwith an application for financial assistance to Ohio Department of Natural Resources under the Ohio Natureworks Grant Program, and

The Mayor or Village Administrator are directed to execute and submit to Ohio Department of Natural Resources a grant application under the Ohio Natureworks Grant Program, and submitting with said grant application all information and attachments required to be submitted with such application, to assist in the determination of the Village's eligibility for such a grant, and

Village Council agrees that it will obligate such funds as are required to satisfactorily complete the project proposed in the grant application and become eligible for reimbursement under the Ohio Natureworks Grant Program.

This Resolution is deemed an emergency, being for the health and welfare of the community and given the short time-line for submission of the application to Ohio Department of Natural Resources, and is passed at a public meeting with a sufficient number of votes to avoid the need for three readings.
