

# VILLAGE OF NEWBURG

## ORDINANCE NO. 07-2017

### AN ORDINANCE TO REPEAL AND RECREATE SECTION 51.01 OF THE MUNICIPAL CODE OF NEWBURG ESTABLISHING SEWORAGE SYSTEM USER CHARGES

#### SECTION I. PURPOSE

WHEREAS, the Village of Newburg operates a waste water collection and treatment system within the village limits for the various classified sanitary users; and

WHEREAS, the Village is authorized to charge for such services; and

WHEREAS, the Village Board on occasion reviews the sewerage system user rates for each user classification and makes changes to these rates as needed;

NOW THEREFORE, the Village Board of the Village of Newburg, Wisconsin, does hereby repeal and recreate Section 51.01 of the Municipal Code to read:

#### SECTION II. REPEAL AND RECREATE

##### **51.01 SEWERAGE SYSTEM USER RATES.**

(A) *Sewer service charges.* Sewer service charges shall be on the basis of estimated water use of the average residence and is designated residential equivalent use (REU). The sewer service charge shall be based on the number of REUs designated for each classification of users. The sewer service charge for each REU is \$145.00 per quarter.

(B) *User classifications:*

- (1) For each residential unit, defined to be a housekeeping unit with 2 bedrooms or more, a monthly sewer service charge of one REU.
- (2) For each efficiency or one-bedroom residential unit, a monthly sewer service charge of three-quarters of one REU.
- (3) For each commercial establishment, defined to be a business or retail, or wholesale or of service nature, a monthly sewer service charge of one REU for each 5 full time equivalent employees.
- (4) For each church or assembly hall, a monthly sewer service charge of one REU.
- (5) For each school or day care facility, a monthly sewer service charge of one REU for each 20 occupants.

- (6) For each Tavern/Bar/Restaurant, a monthly sewer service charge will be assessed as *classified by the County Health Department operational license guidelines for the business portion of the sewer usage.*
- a) Tavern/Bar with No Food Served two REU's.
  - b) Tavern/Bar/Restaurant Food Served three REU's.
  - c) Housekeeping units associated with the Tavern/Bar/Restaurant i.e. property, will be defined separately as reflected in user classifications B (1) and (2).
- (7) For each manufacturing establishment, a monthly sewer service charge of one REU for each 5 full time equivalent employees plus additional REU's based upon estimated water usage for manufacturing operations.

### SECTION III. MISCELLANEOUS

SEVERABILITY. The several sections of this Ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provision, sections or portions thereof of the Ordinance. The remainder of the Ordinance shall remain in full force and effect. Any other Ordinances whose terms are in conflict with the provisions of this Ordinance are hereby repealed as to those terms that conflict.

### SECTION IV. EFFECTIVE DATE

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
