**AN ORDINANCE AMENDING

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF O'FALLON,
ST. CLAIR COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: SNOW ROUTE DESIGNATIONS:

An Ordinance to amend the Code of Ordinances of the City of O'Fallon, Chapter 78, Schedule "IV" be amended to include the following:

Lakeside Drive	From Pine Ridge Court to Percy Drive
Percy Drive	From Lakeside Drive to Autumn Pine Drive
Autumn Pine Drive	From Old Collinsville Road to Percy Drive
Armsleigh Place	All
South Oak Street	From West 3 rd Street to West 2 nd Street
West 2 nd Street	From South Oak Street to South Cherry Street
South Cherry Street	From West 3 rd Street to West 2 nd Street
Emily Street	From North Smiley Street to Bevirt Court
Bevirt Court	From Emily Street to East Wesley Drive
Stonybrook Drive	All
Elisabeth Drive	From Stonybrook Drive to Fairwood Hills Road
Borchers Lane	From Scott Troy Road to Bandmour Place
Bandmour Place	All
