**AN ORDINANCE AMENDING THE REVISED CODE OF ORDINANCES
OF THE VILLAGE OF OREANA, MACON COUNTY, ILLINOIS, SPECIFICALLY
TITLE V: PUBLIC WORKS, CH. 52 WATER and CH. 53 SEWERS**

WHEREAS, the Village currently has Chapters 52 and 53 establishing water and sewer rates for the Village of Oreana, and;

WHEREAS, the Board of Trustees of the Village of Oreana finds that it is in the best interests of the Village to amend Chapters 52 and 53;

NOW, THEREFORE, PURSUANT TO THE VOTE TAKEN BY THE BOARD OF TRUSTEES ON JANUARY 19, 2021 IN FAVOR OF THE PASSAGE OF THIS AMENDMENT TO CHAPTERS 52 and 53, BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF OREANA, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Chapter 52, specifically Section 115, is amended as follows:

§52.115 WATER RATES.

There shall be established the following rates and charges for the use of the water system of the Village, based upon the amount of water consumed as follows:

A. WATER RATES INSIDE VILLAGE.

First 2,000 gallons per month \$23.20 MINIMUM CHARGE
Over 2,000 gallons per month \$10.61 Per Each Additional Thousand Gallons,
Pro-rated to Actual Usage

B. WATER RATES OUTSIDE VILLAGE.

First 2,000 gallons per month \$30.44 MINIMUM CHARGE
Over 2,000 gallons per month \$10.61 Per Each Additional Thousand Gallons,
Pro-rated to Actual Usage

C. BULK SALES.

Per 1,000 gallons \$ 8.25 Per 1,000 Gallons

D. ANNUAL INCREASE

There will be a 3% annual increase in all water rates effective July 1, 2021 and July 1st of each year thereafter.

SECTION 2: Chapter 53, specifically Section 13, is amended as follows:

§53.13 SEWER RATES.

There shall be established the following rates and charges for the use of the water system of the Village, based upon the amount of water consumed as follows:

A. SEWER RATES INSIDE VILLAGE.

(1) Minimum charge per user per month: \$39.00

(2) Usage charge per 1,000 gallons per month: \$2.32 per each additional thousand gallons, pro-rated to actual usage.

B. ANNUAL INCREASE.

There will be a 3% increase in the sewer usage charge, effective July 1, 2021 and July 1st of each year thereafter.

SECTION 3: In all other respects, Chapters 52 and 53 shall remain in full force and effect.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

SECTION 5: The Village Clerk of the Village of Oreana shall publicly post or keep available for inspection by any interested party in the main office of the Village of Oreana this Ordinance Amending the Revised Code of Ordinances Specifically TITLE V: PUBLIC WORKS Chapter 52 WATER and Chapter 53 SEWER.
