

ORDINANCE NO. 2023-14

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF PEORIA, ARIZONA AMENDING CHAPTER 27 OF THE PEORIA CITY CODE (1992) BY AMENDING FEE TABLE 27-5 PERTAINING TO FEES, RENTS, AND CHARGES CHARGED BY THE PARKS AND RECREATION; NEIGHBORHOOD AND HUMAN SERVICES; AND ARTS, CULTURE AND LIBRARY SERVICES DEPARTMENTS AND PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ordained by the Mayor and Council of the City of Peoria as follows:

SECTION 1. Chapter 27 of the Peoria City Code (1992) is amended by amending Fee Table 27-5 pertaining to the fees by the Parks and Recreation; Neighborhood and Human Services; and Arts, Culture and Library Services Departments, which shall read as follows:


Some services may require the purchase of supplies necessary for the activity. The fee includes the actual cost of the program to the City.

SECTION 2. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any Court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 3. This Ordinance shall become effective in the manner provided by law.
