## AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF CERTAIN PROPERTY IN THE FALLBROOK COMMUNITY PLANNING AREA REF: R04-004

## The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. This ordinance implements zoning classifications consistent with the general plan designations for the Meadowood project. The zoning classification of certain real property, as described below, is hereby changed as set forth herein, and more precisely delineated on the Rezone plat, as illustrated on Exhibit A of this Ordinance. All documents are on file with the Clerk of the Board of Supervisors of the County of San Diego.

Section 2. The zoning classification of the real property identified on the Rezone plat is hereby changed as follows:
