

ORDINANCE NO. 10281 (New Series)

**AN ORDINANCE DELETING ADMINISTRATIVE CODE ARTICLE XXXIV
RELATING TO THE COMMUNITY REDEVELOPMENT AGENCY**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. The Board of Supervisors finds and determines that it is necessary to delete Article XXXIV relating to the Community Redevelopment Agency due to changes in State law. This Article is no longer necessary as the State has dissolved redevelopment agencies. The Board now has authority over the Successor Agency. An Oversight Board has also been established pursuant to State Law to approve the Recognized Obligation Payment Schedule and establish mechanics for the unwinding of the former Redevelopment Agency. All former Redevelopment Agency housing assets have been transferred to the County Department of Housing & Community Development.

Section 2. Article XXXIV is hereby deleted from the Administrative Code to read as follows:

~~SEC. 660. — AUTHORIZATION.~~

~~Pursuant to Section 33101 of Part 1, Division 24 of the Health and Safety Code of the State of California, which Part 1 of said Division 24 of said Code is known as the "Community Redevelopment Law," there is a need for the Redevelopment Agency created by Section 33100 of said Law to function in the County of San Diego, and said agency is hereby authorized to transact business and exercise its power under the Community Redevelopment Law.~~


~~SEC. 661. — BOARD OF SUPERVISORS AS AGENCY.~~

~~Pursuant to Section 33200 of the Community Redevelopment Law, the Board of Supervisors of the County of San Diego is hereby declared to be the agency provided in Section 660 hereof, and all the rights, powers, duties, privileges, and immunities vested by the Community Redevelopment Law in such agency shall be, and are, vested in said Board of Supervisors.~~

Section 3. This Ordinance shall take effect and be in force sixty (60) days after the date of its passage, and before the expiration of fifteen (15) days after its passage, a summary shall be published once with the names of the members voting for and against the same in San Diego Commerce, a newspaper of general circulation published in the County of San Diego.
