**AN ORDINANCE AMENDING THE COMPENSATION ORDINANCE
AND ESTABLISHING COMPENSATION**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 6. Section 1.9.10 of the Compensation Ordinance is hereby amended to read as follows:

SECTION 1.9.10: FEDERAL COURT OR APPELLATE ASSIGNMENT

Eligible employees in the Confidential Paralegal (class no. 003934) and Confidential Senior Paralegal (class no. 002931) classifications, who are assigned to assist in motion or trial preparation in Federal District Court or in the preparation of appellate briefs in a State Court of Appeal, U.S. Court of Appeals for the Ninth Circuit or the United States Supreme Court, shall be compensated an additional five (5%) in addition to the employee's base wage rate. The premium shall apply to paid leave, but shall not apply to terminal payoff.

Section 7. Effective Date. Section 2 of this ordinance affect compensation and shall take effect upon adoption and all other sections of this ordinance shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.
