AN ORDINANCE AMENDING ORDINANCE 9831, THE COUNTY'S PARTICIPATION IN THE CALIFORNIA COMMISSION ON PEACE OFFICER STANDARDS AND TRAINING NON-REIMBURSABLE PROGRAM FOR PUBLIC ASSISTANCE INVESTIGATION PEACE OFFICERS AND ACCEPTING THE REQUIREMENTS OF THE PENAL CODE RELATING TO THE TRAINING OF LAW ENFORCEMENT OFFICERS

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1: The Board of Supervisors finds and determines that District Attorney's Public Assistance Fraud unit was transferred to the Department of Child Support Services, and was renamed the Bureau of Public Assistance Investigations. Peace officers employed by the District Attorney's Public Assistance Fraud unit participated in the Commission on Peace Officer Standards and Training Non-reimbursable Program. This ordinance is intended establish the Board of Supervisor's desire to have the peace officers employed by the Department of Child Support Services to participate in the Commission on Peace Officer Standards and Training Non-reimbursable Program.

Section 2: Ordinance No. 9831 is hereby amended to read as follows:

The Board of Supervisors of the County of San Diego declares that it desires the peace officers employed by the Department of Child Support Services to participate in the Commission on Peace Officer Standards and Training Non-Reimbursable Program.

Pursuant to Section 13510, Chapter 1, of Title 4, Part 4 of the California Penal Code, the Department of Child Support Services will adhere to the standards for recruitment and training of peace officers established by the Commission on Peace Officer Standards and Training.

Pursuant to Section 13512, Chapter 1 of Title 4, Part 4 of the California Penal Code, the Commission and its representatives may make such inquiries as deemed necessary to ascertain that the peace officer personnel of the Department of Child Support Services adhere to the standards for recruitment and training established by the California Commission on Peace Officer Standards and Training.

Section 3: This ordinance shall take effect and be in force thirty days after its passage, and before the expiration of fifteen days after its passage, a summary hereof shall be published once with the names of the members of this Board voting for and against it in a newspaper of general circulation published in the County of San Diego.
