ORDINANCE ADDING SECTION 72.169.98.1., 72.169.98.2., AND 72.169.8.2. AND AMENDING SECTIONS 72.169.38.1. and 72.161.38.1. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.98.1. of the San Diego County Code is added

Section 72.169.98.1. ALPINE. The prima facie speed limit on Arnold Way from the south line of Alpine Boulevard easterly to the west line of Harbison Canyon Road is hereby decreased to and established at 45 miles per hour.

Section 72.169.98.2. of the San Diego County Code is added.

Section 72.169.98.2. ALPINE. The prima facie speed limit on Arnold Way from the east line of Harbison Canyon Road easterly to the west line of Tavern Road is hereby decreased to and established at 40 miles per hour.

Section 72.169.8.2. of the San Diego County Code is added.

Section 72.169.8.2. RAINBOW. The prima facie speed limit on Rice Canyon Road from the north line of State Highway 76 northerly to the easterly limits of Eighth Street is hereby decreased to and established at 30 miles per hour.

Section 72.169.38.1. of the San Diego County Code is amended.

Section 72.169.38.1. LAKESIDE. The prima facie speed limit on Highway 8 Business from the west line of Lake Jennings Park Road westerly to the easterly limits of the City of El Cajon is hereby decreased to and established at 45 miles per hour.

Section 72.161.38.1. of the San Diego County Code is amended.

Section 72.161.38.1. ESCONDIDO. The prima facie speed limit on Bear Valley

Parkway from the north line of State Highway 78 northerly to the southerly limits of the City of Escondido (near Boyle Avenue) is hereby decreased to and established at 50 miles per hour.
