ORDINANCE AMENDING SECTIONS 72.162., 72.162.39.3., 72.161.35.2., AND 72.169.74.5. AND DELETING SECTION 72.161.35.3. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.162. of the San Diego County Code is amended to read as follows:

Section 72.162. RANCHO SANTA FE. The prima facie speed limit on Lomas Santa Fe Drive/Linea del Cielo from the Solana Beach City Limit easterly to a point 1600 feet west of the west line of El Camino Real is hereby decreased to and established at 45 miles per hour.

Section 72.162.39.3. of the San Diego County Code is amended to read as follows:

Section 72.162.39.3. 4S RANCH. The prima facie speed on Rancho Bernardo Road from the San Diego City Limit (350 feet west of Via Del Campo) westerly to Camino del Norte is hereby decreased to and established at 45 miles per hour.

Section 72.161.35.2. of the San Diego County Code is amended to read as follows:

Section 72.161.35.2. VALLEY CENTER. The prima facie speed limit on Woods Valley Road from Valley Center Road easterly to the west line of North Lake Wohlford Road is hereby decreased to and established at 40 miles per hour.

Section 72.169.74.5. of the San Diego County Code is amended to read as follows:

Section 72.169.74.5. FALLBROOK. The prima facie speed limit on Gird Road from the north line of SH-76 northerly to a point 1000 feet south of the south line of Oak Cliff Drive is hereby decreased to and established at 45 miles per hour.

Section 72.161.35.3. of the San Diego County Code is deleted.


