## Ordinance No. 10531 (N.S.)

## AN ORDINANCE AMENDING SECTIONS 161.11, 161.12, AND 364.6 OF THE SAN DIEGO COUNTY ADMINISTRATIVE CODE RELATING TO MEDICAL EXAMINER FEES AND CHARGES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. The Board of Supervisors finds and determines that the County Department of the Medical Examiner fees and charges must be adjusted to reflect actual expenses incurred by the Medical Examiner in the administration of various services and responsibilities. The amendments made by this ordinance will reduce and eliminate certain fees and charges while allowing the Medical Examiner to recover actual expenses for certain services provided by the Department.

Section 2. Section 161.11 of the San Diego Administrative Code is hereby repealed in its entirety.

Section 3. Section 161.12 of the San Diego County Administrative Code is hereby repealed in its entirety.

Section 4. Section 364.6 of the San Diego County Administrative Code is hereby amended to read as follows:
