

ORDINANCE NO.10737 (NEW SERIES)

**ORDINANCE AMENDING SECTIONS 72.169.94.1., 72.161.40.4., AND 72.169.75.1.
AND ADDING SECTION 72.161.44.2. OF THE SAN DIEGO COUNTY CODE
RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS
IN SAN DIEGO COUNTY**

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.94.1. of the San Diego County Code is amended to read as follows:

Section 72.169.94.1 PINE VALLEY. The prima facie speed limit on Old Highway 80 from Mile Post 4.5 easterly to a point 380 feet west of Pine Valley Road (Mile Post 5.0) is hereby decreased to and established at 45 miles per hour.

Section 72.161.40.4. of the San Diego County Code is amended to read as follows:

Section 72.161.40.4. HARMONY GROVE. The prima facie speed limit on Kauana Loa Drive from the east line of Country Club Drive easterly to the Escondido City Limit (Oak View Way) is hereby decreased to and established at 35 miles per hour.

Section 72.169.75.1. of the San Diego County Code is amended to read as follows:


Section 72.169.75.1. FALLBROOK. The prima facie speed limit on Gum Tree Lane from the east line of Mission Road easterly to the west line of Live Oak Park Road is hereby decreased to and established at 35 miles per hour.

Section 72.161.44.2. of the San Diego County Code is added to read as follows:

Section 72.161.44.2. RANCHO SANTA FE. The prima facie speed limit on Aliso Canyon Road from the south line of Avenida del Duque southerly to the north line of El Camino del Norte is hereby decreased to and established at 45 miles per hour.
