AN ORDINANCE AMENDING THE COMPENSATION ORDINANCE AND ESTABLISHING COMPENSATION

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Appendix One of the Compensation Ordinance is hereby amended by establishing the following classifications and compensation in the Classified Service, effective March 11, 2022:

Section 2. Subsection (a)(1) of Section 5.9.1 of the Compensation Ordinance is hereby amended as follows:

SECTION 5.9.1: HOLIDAYS.

- (a) <u>Establishing Holidays.</u> County holidays shall be those established by resolution or ordinance of the Board of Supervisors pursuant to Administrative Code, Article III, General Rules, Section 57, Holidays/Office Hours.
 - (1) The County shall observe the following holidays:
 - 1. Independence Day shall be observed on July 4
 - 2. Labor Day, First Monday in September
 - 3. Veterans Day, November 11
 - 4. Thanksgiving Day, Fourth Thursday in November
 - 5. Day after Thanksgiving, Fourth Friday in November
 - 6. Christmas Day, December 25
 - 7. New Year's Day, January 1
 - 8. Martin Luther King, Jr. Day, Third Monday in January
 - 9. President's Day, Third Monday in February
 - 10. Cesar Chavez Day, March 31
 - 11. Memorial Day, Last Monday in May
 - 12. Juneteenth, June 19

Section 3. Effective Date. Sections 1 and 2 of this ordinance shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.
