ORDINANCE ADDING SECTION 72.160.8. AND AMENDING SECTIONS 72.160.9., 72.161.41., & 72.161.41.1. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.160.8. of the San Diego County Code is added to read as follows:

SEC. 72.160.8. SPRING VALLEY. The prima facie speed limit on Austin Drive/Montemar Drive from the west line of South Barcelona Street to the north line of Helix Street is hereby decreased to and established at 30 miles per hour.

Section 72.160.9. of the San Diego County Code is amended to read as follows:

SEC. 72.160.9. SPRING VALLEY. The prima facie speed limit on Austin Drive from Sweetwater Springs Boulevard westerly to South Barcelona Street is hereby decreased to and established at 40 miles per hour.

Section 72.161.41. of the San Diego County Code is amended to read as follows:

SEC 72.161.41. BONSALL. The prima facie speed limit on Gopher Canyon Road from the east line of East Vista Way to the west line of Spa Havens Way is hereby decreased to and established at 45 miles per hour.

Section 72.161.41.1. of the San Diego County Code is amended to read as follows:

SEC 72.161.41.1. BONSALL. The prima facie speed limit on Gopher Canyon Road from the east line of Spa Havens Way to the west line of Champagne Boulevard/Old Highway 395 is hereby decreased to and established at 50 miles per hour.
