ORDINANCE NO. 10796 (N.S.)

AN ORDINANCE TO AMEND SECTIONS 21.102 AND 21.1901 OF THE SAN DIEGO COUNTY CODE OF REGULATORY ORDINANCES RELATING TO SHERIFF'S DEPARTMENT FEES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Section 21.102 of the Code of Regulatory Ordinances is amended to read as follows:

SEC. 21.102. LICENSE REQUIRED FROM THE SHERIFF.

The following activities require a license for which the Sheriff is the Issuing Officer:

- (a) Adult Entertainment Employee License
- (b) Adult Entertainment Establishment License
- (c) Amusement Establishment and Devices
- (d) Bathhouses
- (e) Bingo License
- (f) Cannabis Operation Certificate
- (g) Carnival or Circus License
- (h) Casino Party License
- (i) Charitable Solicitor Registration
- (j) Concealed Weapons License
- (k) Entertainment Establishments
- (l) Entertainment Managers
- (m) Explosives Permit
- (n) Firearms Dealers
- (o) Fireworks Permit
- (p) Fortune Telling
- (q) Holistic Health Practitioners
- (r) Junk Yards and Motor Vehicle Wrecking Yards
- (s) Massage Establishments
- (t) Massage Technicians
- (u) Massage Technician Trainees
- (v) Merchandise Coupon Distributor

Section 2. Section 21.1901 of the Code of Regulatory Ordinances is amended to read as follows:

SEC. 21.1901. FEES.

The fees for the licenses, permits and registration certificates issued by the Sheriff and services provided by the Sheriff pursuant to this code shall be as follows:

(a) LICENSES AND PERMITS

- (1) Adult Entertainment Employee License: Initial fee \$325, renewal fee \$296.
- (2) Adult Entertainment Establishment License: Initial fee \$885, renewal fee \$826.
- (3) Amusement Establishment License: Annual fee \$732 plus \$60 per device.
- (4) Bath-house Permit: Initial fee \$721, renewal fee \$692.
- (5) Bingo License: Annual fee \$50.
- (6) Cannabis Operation Certificate: Annual fee \$49,460
- (7) Carnival or Circus License: Annual fee \$396 plus \$100 per day.
- (8) Casino Party License: Event fee \$396.
- (9) Charitable Solicitor Registration: No fee.

(10) Concealed Weapons License: An increase to the Initial Fee will be phased in over three calendar years, beginning on the effective date of the ordinance establishing this increase. That phase-in will be as follows: Initial Fee \$100 (as of the effective date), \$138 (as of one year after the effective date), \$176 (as of two years after the effective date). Renewal Fee \$25, in addition to fees to the State of California, the Department of Justice and the FBI. Any license amendment \$10.

(11) Entertainment Establishment License: Annual fee \$348.

(12) Entertainment Establishment Manager Registration: Annual fee \$124.

(13) Explosives Permit: Initial fee \$741, renewal fee \$507.

(14) Firearms Dealer Permit: Initial fee \$543, renewal fee \$514.

(15) Fireworks Permit: Initial fee \$376, renewal fee \$347.

(16) Fortune Telling License: Initial fee \$328, renewal fee \$299.

(17) Junk Yards or Motor Vehicle Wrecking Yards License: Annual fee \$463.

(18) Massage Establishment License: Initial fee \$398, renewal fee \$379.

(19) Merchandise Coupon Distributor: Annual fee \$212.

(20) Outdoor Assembly License: Event license \$538.

(21) Outdoor Assembly Manager Registration: Manager event registration \$124.

(22) Pawnbroker or Second Hand Dealer License: Initial fee \$497, renewal fee \$468.

(23) Permanent Amusement Rides and Go-cart Centers Permit: Annual fee \$719.

(24) Public Dance License: Initial fee \$279, renewal fee \$249.

(25) Public Dance Manager Registration: Annual fee \$124.

(26) Security Alarm Systems Permit: Permit fee \$176.

(27) Solicitor's ID Cards: Initial fee \$124, renewal fee \$95.

(28) Solicitor's License: Initial fee \$245, renewal fee \$183.

(29) Swap Meets License: Initial fee \$400 plus \$24 per stall, renewal fee \$370 plus \$24 per stall.

(30) Taxicab Drivers Identification Card: Initial fee \$121, renewal fee \$44. Fee for changes to card between renewals: \$29.

(31) Taxicabs and Taxicab Operator's License: Initial fee \$183, plus \$172 per cab inspection fee. Renewal fee \$154, plus \$172 per cab inspection fee.

(32) Teenage Public Dances License: Initial fee \$279, renewal fee \$249.

(b) SERVICES

(1) Copies of Reports: \$20.

(2) Records Search/Criminal History Copies: \$14.


(3) Police Clearance Letter (Good Conduct Letter): \$59

- (4) Fingerprint Service by License Division: \$29.
- (5) Copies of Evidence Photos: \$25.
- (6) Copies of Crime Lab Reports: \$14.

Section 3. This ordinance shall take effect and be in force thirty days after its passage, and before the expiration of fifteen days after its passage, a summary hereof shall be published once with the names of the members of this Board voting for and against it in the Daily Transcript newspaper of general circulation published in the County of San Diego.
