ORDINANCE AMENDING SECTIONS 72.169.41., 72.163.19.3., 72.169.19.4., 72.161.96., AND 72.162. AND ADDING SECTION 72.243.12. OF THE SAN DIEGO COUNTY CODE RELATING TO TRAFFIC REGULATIONS ON ROADS IN THE COUNTY OF SAN DIEGO

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.169.41. of the San Diego County Code is hereby amended:

SEC. 72.169.41. LAKESIDE. The prima facie speed limit on Lakeshore Drive from the east line of Vine Street to the west line of Petite Lane is hereby decreased to and established at 35 miles per hour.

Section 72.169.19.3. of the San Diego County Code is hereby amended:

SEC. 72.169.19.3. JAMUL. The prima facie speed limit on Proctor Valley Road from the south line of SH-94 southerly to Melody Lane is hereby decreased to and established at 35 miles per hour.

Section 72.169.19.4. of the San Diego County Code is hereby amended:

SEC. 72.169.19.4. JAMUL. The prima facie speed limit on Proctor Valley Road Melody Lane southerly to a point 800 feet west of Echo Valley Road is hereby decreased to and established at 45 miles per hour.

Section 72.161.96. of the San Diego County Code is hereby amended:

SEC. 72.161.96. RANCHO SANTA FE. The prima facie speed limit on Linea del Cielo from La Floresta (private road) easterly to a point 180 feet east of the east line of El

Fuego is hereby decreased to and established at 35 miles per hour.

Section 72.162. of the San Diego County Code is hereby amended:

SEC. 72.162. RANCHO SAN DIEGUITO. The prima facie speed limit on Lomas Santa Fe Drive from the Solana Beach City Limit (at Highland Drive) easterly to La Floresta

(private road) is hereby decreased to and established at 40 miles per hour.

Section 72.243.12. of the San Diego County Code is added:

SEC. 72.243.12. VEHICLES RESTRICTED FROM MONTEZUMA VALLEY ROAD.

Except as otherwise permitted by law, vehicles and combinations of vehicles of a total

length in excess of 60 feet shall not be permitted to travel on Montezuma Valley Road

between San Felipe Road to Palm Canyon Drive. An alternative route for vehicles of length

in excess of 60 feet has been identified as follows: San Felipe Road, State Route 78,

Borrego Springs Road.
