ORDINANCE NO. 10905 (N.S.)
AN ORDINANCE AMENDING THE SAN DIEGO COUNTY ADMINISTRATIVE CODE ARTICLE
XX SECTION 364.6, RELATING TO MEDICAL EXAMINER FEES AND CHARGES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. The Board of Supervisors finds and determines that the San Diego County Department of the Medical Examiner fees and charges must be adjusted to reflect the actual expenses incurred by the Department. The amendments made by this ordinance are intended to allow the Medical Examiner to recover actual expenses for certain services provided by the Department.

Section 2. Section 364.6 of the San Diego County Administrative Code is hereby amended to read as follows:

SEC. 364.6. DEPARTMENT OF THE MEDICAL EXAMINER.

The following fees and charges shall be paid to the San Diego County Medical Examiner or the County collection agent.
