

ORDINANCE NO.: 10907(N.S.)

AN ORDINANCE AMENDING SECTION 364.3 OF THE SAN DIEGO COUNTY ADMINISTRATIVE CODE, RELATING TO FEES CHARGED BY THE DEPARTMENT OF AGRICULTURE, WEIGHTS AND MEASURES

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. The Board of Supervisors (Board) finds and determines that the Department of Agriculture, Weights and Measures' costs of doing business has increased since the hourly rate that serves as the basis for many of the Department's current fees was established. The Board also finds and determines that it is necessary to adopt new fees to existing programs. Accordingly, the Board of Supervisors finds and determines that it is necessary to adjust the fees charged by the Department, to recover as much of the Department's costs as feasible for the programs and services it provides. The Board further finds and determines that the new and adjusted fees do not exceed the reasonable costs of providing the affected programs and services.

Section 2. Section 364.3 of the San Diego County Administrative Code is hereby amended to read as follows:

**SEC. 364.3. FEES FOR THE DEPARTMENT OF AGRICULTURE, WEIGHTS AND MEASURES.**

The following fees shall be paid to the Department of Agriculture, Weights and Measures for the specified applications, permits, registrations, inspections, and other related services:

Section 3. This ordinance shall take effect and be in force 30 days after its passage, and before the expiration of fifteen days after its passage, a summary shall be published once with the names of the members voting for and against the same in the Daily Transcript, a newspaper of general circulation published in the County of San Diego.

Section 4. Operative Date: This Ordinance shall be operative on July 1, 2024.
