ORDINANCE AMENDING SECTIONS 72.161.46.2., 72.161.89.1, AND 72.162.39.2. AND ADDING SECTIONS 72.161.46.4 AND 72.161.99. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.46.2. of the San Diego County Code is amended:

SEC. 72.161.46.2. VISTA. The prima facie speed limit on that portion of Hutchison Street from Harris Drive easterly to East Vista Way is hereby decreased to and established at 40 miles per hour.

Section 72.161.89.1. of the San Diego County Code is amended:

SEC. 72.161.89.1. RANCHO SANTA FE. The prima facie speed limit on Paseo Delicias from the east line of El Montevideo/La Valle Plateada to El Camino del Norte is hereby decreased to and established at 45 miles per hour.

Section 72.162.39.2. of the San Diego County Code is amended:

SEC. 72.162.39.2. 4S RANCH. The prima facie speed limit on Carmel Valley Road/Bernardo Center Drive from the San Diego City Limit (at Winecreek Road) easterly to the San Diego City Limit (at Camino Crisalida) is hereby decreased to and established at 50 miles per hour.

Section 72.161.46.4. of the San Diego County Code is added:

SEC. 72.161.46.4. VISTA. The prima facie speed limit on Hutchison Street from Harris Drive to Barsby Street is hereby decreased to and established at 35 miles per hour.

Section 72.161.99. of the San Diego County Code is added:

SEC. 72.161.99. RANCHO SAN DIEGUITO. The prima facie speed limit on Del Dios Highway from El Camino del Norte to a point 500' east of Luna de Miel is hereby decreased to and established at 50 miles per hour.
