ORDINANCE AMENDING SECTIONS 72.161.90., 72.162.31., 72.169.33., AND  
72.169.97. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON  
COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY

The Board of Supervisors of the County of San Diego ordains as follows:

Section 72.161.90. of the San Diego County Code is amended:

SEC. 72.161.90. RANCHO SANTA FE. The prima facie speed limit on Via de Santa Fe from the north line of Calzada del Bosque northerly to the south line of Via de la Valle is hereby decreased to and established at 35 miles per hour.

Section 72.162.31. of the San Diego County Code is amended:

SEC. 72.162.31. FAIRBANKS RANCH. The prima facie speed limit on El Apajo/Via de Santa Fe from the west line of San Dieguito Road to the south line of Calzada del Bosque is hereby decreased to and established at 40 miles per hour.

Section 72.169.33. of the San Diego County Code is amended:

SEC. 72.169.33. EL CAJON. The prima facie speed limit on Fuerte Drive from the La Mesa City Limit (west of Grossmont Boulevard) easterly to the west line of Chase Avenue is hereby decreased to and established at 35 miles per hour.

Section 72.169.97. of the San Diego County Code is amended:

SEC. 72.169.97. ESCONDIDO. The prima facie speed limit on Rock Springs Road from the Escondido city limit (near Hagen Oakes Court) westerly to the Escondido city limit


ORDINANCE AMENDING SECTIONS 72.161.90., 72.162.31., 72.169.33., AND
