ORDINANCE NO. <u>9401</u> (NEW SERIES)

AN ORDINANCE AMENDING SECTION 439.2 OF THE SAN DIEGO COUNTY ADMINISTRATIVE CODE RELATING TO THE REGISTRAR OF VOTERS FEES FOR RECORDS AND SERVICES

The Board of Supervisors of the County of San Diego do ordain as follows:

Section 1. Section 439.2 of the San Diego County Administrative Code is hereby

amended to read as follows:

SEC. 439.2. FEES FOR RECORDS AND SERVICES. The Registrar of Voters may charge and collect the following fees in connection with providing to members of the public the records and services indicated:

- (a) Retrieval and copying of campaign financial records pursuant to Government Code section 81008
 - 1. Records over five years old . . . \$5 per request
 - 2. Copies of campaign records . . . \$.10 per page
- (b) Copies of other records subject to public disclosure and maps (8 ¹/₂" x 11" and 11" x 17")
 - 1. Customer makes copies: \$.50 per first page, plus \$.20 per additional page
 - 2. Copies prepared for customer: \$.55 per first page, plus \$.30 per additional pages
- (c) Searching records or files
 - 1. On-line search for voter record: \$1.75 per record
 - 2. Staff research: \$22 per hour
 - 3. Technical support: \$75 per hour
- (d) Providing copies of documents by facsimile machine (Telefax) \$2.20 per setup, plus \$.55 per page
- (e) Computer generated reports

- Electronic transfer of absentee voter information (Bulletin Board System): \$50 set-up fee plus: up to 50,000 registered voters: \$125 50,001 – 100,000 registered voters: \$250 100,001 to 200,000 registered voters: \$500 200,001 to 300,000 registered voters: \$750 300,001 or more registered voters: \$850
- 2. Master street CD: \$70
- 3. District index CD: \$70
- 4. Statement of Vote: \$100
- 5. Voter file on CD ROM
 - (a) Countywide: \$385
 - (b) Selection by jurisdiction: \$30 set-up fee, plus: up to 50,000 registered voters: \$45 50,001 - 100,000 registered voters: \$110 100,001 - 200,000 registered voters: \$175 200,001 - 300,000 registered voters: \$240 300,001 - 750,000 registered voters: \$310 750,001 - 1,400,000 and above registered voters: \$385
- 6. Voter list (paper copy) with special master voter file sort: \$50, plus \$1.50 per 1,000 names
- 7. Pressure-sensitive voter address labels: \$75, plus \$.04 each
- (f) Candidate statements (State, County, Districts and Boards):
 - 1. Countywide office: \$6,550
 - 2. Board of Supervisors, County Board of Education: \$1,310
 - 3. S.D. Unified School District:
 - (a) no photograph: \$1,095
 - (b) photograph: \$1,175

- 4. State Legislative Offices and all Special Districts:
 - (a) 200/250 words, (half page): \$100 set-up fee, plus \$5 per 1,000 registered voters in district
 - (b) 400 words, (full page): \$100 set-up fee, plus \$10 per 1,000 registered voters in district
- (g) Certification of documents: \$1.50 per document
- (h) Notice of Intent to Circulate County initiative petition: \$200 (refundable if certified sufficient within one year)
- (i) Computer online dialback access for City Clerk signature verification
 - 1. Training and set-up: \$150
 - 2. Additional training and support: \$75/hour
- (j) Maps
 - 1. Customer-ready maps Countywide with communities, district boundaries and roads (36" x 48") \$8
 - 2. Custom maps: \$50/hour development charge, plus materials cost as follows:

8 ½" x 11"	\$1.50
11" x 17"	\$1.50
17" x 22"	\$2.25
24" x 36"	\$3.00
28" x 40"	\$4.00
36" x 48"	\$6.00

Custom maps include communities, district boundaries, roads, parcels and precincts as specified in the map order. Additional copies provided at materials cost only.

Section 2. Effective Date

This ordinance shall take effect 30 days after its adoption. Within 15 days after the date of adoption of this ordinance, a summary shall be published once with the names of those members voting for and against the same in a newspaper of general circulation published in the County of San Diego.
