AN ORDINANCE AMENDING THE COMPENSATION ORDINANCE AND ESTABLISHING COMPENSATION IMPLEMENTING A NEGOTIATED TWO YEAR EXTENSION OF THE MEMORANDA OF AGREEMENT WITH THE SERVICE EMPLOYEES INTERNATIONAL UNION, LOCAL 221, CLC DEPUTY DISTRICT ATTORNEY ASSOCIATION PUBLIC DEFENDERS ASSOCIATION OF SAN DIEGO COUNTY SAN DIEGO COUNTY COUNSELS ASSOCIATION SUPERVISING PROBATION OFFICERS ASSOCIATION DISTRICT ATTORNEY INVESTIGATORS ASSOCIATION

The Board of Supervisors of the County of San Diego ordains as follows:

Section 1. Appendix One of the Compensation Ordinance is hereby amended by establishing compensation for classes designated AE, AM, AS, CC, CL, CM, CR, CS, DA, DI, DM, FS, HS, MM, PD, PM, PR, PS, RN, SO, SS, and SW, effective June 18, 2010.

Section 2. Subsection (d) of Section 5.1.6 of the Compensation Ordinance is hereby amended to read as follows:

SECTION 5.1.6: FLEXIBLE BENEFITS PLAN:

- County Contributions Toward Flexible Benefit Plan. Insurance premium costs shall be (d) borne by the employee excepting that the County shall make the following contribution toward the Flexible Benefits Plan (which includes health insurance). The employee's insurance premium costs will be reduced by the amount the employee elects to distribute to his or her insurance premium costs from the County's contribution toward the Flexible Benefits Plan. The County's contribution toward the Flexible Benefits Plan shall be:
 - (1) Employees in classes designated EM, NA, NE, and UM under the UCL Benefit Program.
