**RESOLUTION 2022-06**

**RESOLUTION OF SUPPORT AND COMMITMENT OF LOCAL FUNDS**

**WHEREAS**, the City of Troy, Illinois, is applying to Madison County Building & Zoning for a FY 2022 \$15,000 Environmental Grant; and

**WHEREAS**, it is necessary that an application be made and agreements be entered into with Madison County; and

**WHEREAS**, cost of the project are such that financial participation by the grantee is necessary in conjunction with Environmental Grant funds.

**NOW, THEREFORE, BE IT RESOLVED** as follows:

- 1) That the City apply for a grant under the terms and conditions of Madison County and shall enter into and agree to the understandings and assurances contained in said application.
- 2) That the Mayor, City Treasurer, City Clerk, and/or City Administrator on behalf of the City execute such documents and all other documents necessary for the carrying out of said application.
- 3) That the Mayor, City Treasurer, City Clerk, and/or City Administrator are authorized to provide such additional information as may be required to accomplish the obtaining of such grant.
- 4) That the City of Troy, Illinois does hereby commit matching funds in the amount of at least 20% of the \$15,000 grant (i.e., \$3,000) for use in conjunction with an Environmental Grant.
- 5) That the City of Troy, Illinois will use the Environmental Grant for storm sewer improvements that address flooding and erosion at the intersection of Creekside Drive and Avalon Drive.
- 6) That the City currently estimates the project to cost \$38,000, so the local match is estimated to be \$23,000.

**PASSED** by the City Council of the City of Troy, Madison County, Illinois, approved by the Mayor, and deposited in the office of the City Clerk this 18<sup>th</sup> Day of January 2022.
