**RESOLUTION CONCERNING REVIEW OF CLOSED SESSION MINUTES  
HELD BY THE CITY COUNCIL OF THE CITY OF TROY, ILLINOIS

**WHEREAS**, the Troy City Council and its Committees are governed by the provisions of 5 ILCS 120, Illinois Open Meetings Act, concerning the management of minutes of closed session meetings of the Council and its Committees; and

**WHEREAS**, 5 ILCS 120, paragraph 2.06 (as amended) of the Open Meetings Act requires that a public body meet every six months, or as soon as practicable, to review the minutes of closed sessions and determine whether said minutes must remain closed or may be opened to public review; and

**WHEREAS**, the minutes of all closed sessions held through March 31, 2022, were reviewed by the Troy City Council on October 4, 2021; and

**WHEREAS**, the City Council has determined that all or portions of the minutes of some closed sessions should be divulged, and that all or portions of the minutes of some closed sessions should remain confidential.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:**

Continue to keep contents confidential on the basis of 5 ILCS 120/2(c)5, purchase or lease of real property for the use of the public body

City Council Meeting 12/20/2021  
Continue to keep contents confidential on the basis of 5 ILCS 120/2(c)2, collective bargaining matters; and 5 ILCS 120/2(c)6, setting a price for sale or lease of real property owned by the public body

City Council Meeting 03/07/2022  
Continue to keep contents confidential on the basis of 5 ILCS 120/2(c)2, collective bargaining matters

City Council Meeting 03/21/2022  
Continue to keep contents confidential on the basis of 5 ILCS 120/2(c)2, collective bargaining matters; and 5 ILCS 120/2(c)11, potential litigation

**SECTION 5:** That the City Clerk shall prepare copies of those portions of the minutes of the closed meetings which are to be opened and shall make those portions of the minutes available for public inspection within a reasonable time after the date of the adoption of this resolution, and that the City Clerk shall not divulge those portions of the minutes of the closed meetings which the City Council has resolved to keep confidential.
