# A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF UNDERSTANDING (Cole Property)

WHEREAS, the City Council for the City of Troy, Illinois, has determined that it is in the best interests of the City to enter into a Memorandum of Understanding with Patricia Leigh and Gary Lee COLE; and

WHEREAS, the City believes that same is the best interest of the health, safety and general welfare of its citizens.

# NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:

- 1. The recitals set forth above are hereby incorporated herein as if fully set forth.
- 2. The Mayor of the City of Troy, Illinois, is hereby authorized to execute and enter into the attached Memorandum of Understanding with Patricia Leigh and Gary Lee COLE, and is further authorized to take all actions and sign all documents necessary to fulfill the intent of this Resolution.
- 3. This Resolution shall be in effect following its passage, approval and publication as provided by law.

## MEMORANDUM OF UNDERSTANDING

Whereas, Patricia Leigh and Gary Lee COLE (jointly "Owners"), own the property at 8740 State Route 162, Troy, Illinois; further identified as Parcel No. 09-2-22-10-20-401-001 in Madison County, Illinois; and

Whereas, Owners have agreed to annex the Property located at 8740 State Route 162, Troy, Madison County, Illinois, into the City of Troy, Illinois ("City"); and

Whereas, the actions of the Owners set forth in the previous two (2) paragraphs are contingencies which are required to occur prior to performance of the actions of the City set forth in the following paragraphs; and

Whereas, in exchange for the forgoing actions of Owners, the City has agreed to abate 100% of the ad valorem taxes on the Annexed Property for the next ten (10) years; and

Whereas, in further exchange for the forgoing, the City has agreed to reduce the water rate charged to the owners of this property to the "in town" rate; and

Whereas, in further exchange for the forgoing, the City has agreed to allow for an accessory use building on the property, under residential zoning, providing the exception for a two acre or larger lot, which is a maximum square footage of 80% of the ground floor area of the principal structure not to exceed 2,500 square feet; and

Whereas, in further exchange for the forgoing, the City has agreed to provide Owners, one (1) sewer tap for Parcel Nos. 09-2-22-10-20-401-001 in Madison County, Illinois. The tap is meant to run with the property and not the Owners.

**NOW THEREFORE**, the parties to this Memorandum of Understanding do hereby agree to the forgoing, this day of June, 2023.
