RESOLUTION OF SUPPORT AND COMMITMENT OF LOCAL FUNDS

WHEREAS, the City of Troy, Illinois, is applying to Madison County Building & Zoning for a FY 2024 \$15,000 Environmental Grant; and

WHEREAS, it is necessary that an application be made and agreements be entered into with Madison County; and

WHEREAS, cost of the project are such that financial participation by the grantee is necessary in conjunction with Environmental Grant funds.

NOW, THEREFORE, BE IT RESOLVED as follows:


- 1) That the City apply for a grant under the terms and conditions of Madison County and shall enter into and agree to the understandings and assurances contained in said application.
- 2) That the Mayor, City Treasurer, City Clerk, and/or City Administrator on behalf of the City execute such documents and all other documents necessary for the carrying out of said application.
- 3) That the Mayor, City Treasurer, City Clerk, and/or City Administrator are authorized to provide such additional information as may be required to accomplish the obtaining of such grant.
- 4) That the City of Troy, Illinois does hereby commit matching funds in the amount of at least 20% of the \$15,000 grant (i.e., \$3,000) for use in conjunction with an Environmental Grant.
- 5) That the City of Troy, Illinois will use the Environmental Grant for storm sewer improvements that address stormwater erosion that is damaging private property at 260 and 273 Harbor Mill Drive.
- 6) That the City currently estimates the project to cost \$25,836.40, so the local match is estimated to be \$10,836.40.

PASSED by the City Council of the City of Troy, Madison County, Illinois, approved by the Mayor, and deposited in the office of the City Clerk this 16th day of January 2024.
