# A RESOLUTION AUTHORIZING THE CONTINUING SUPPORT OF THE AMERICANS WITH DISABILITIES ACT TRANSITION PLAN

WHEREAS, the City Council for the City of Troy, Illinois, believes that it is necessary and in the best interest of the City to continue to support the Americans with Disabilities Transition Plan prepared by Oates Associates, Inc. that develops, establishes, and sets forth reasonable objectives for making its facilities accessible to all people, including those with disabilities, and

**WHEREAS**, the Americans with Disabilities Transition Plan was originally adopted by the City on June 20, 2016 and is attached as Exhibit A.

WHEREAS, the 2016 Plan identifies the City Administrator as the ADA Coordinator, and he/she is the primary point of contact on all issues related to ADA accessibility in the City of Troy. He/ she also oversees the requirements outlined in the ADA notice to the public and the grievance procedure. The Plan directs all written requests be sent to the Assistant to the City Administrator.

**WHEREAS**, the City has completed projects identified in the plan including new sidewalks on W. Clay Street, Market Street (east of Hickory Street), new curb ramps at Dale Drive and Austin Drive, and grinding bumps from sidewalks in Ward 1.

**WHEREAS**, the City has completed updates to its website and policies that make information more accessible to its residents.

**WHEREAS**, the City plans to continue to improve sidewalks that are prioritized in the plan including new sidewalks on E. Clay Street and on Market Street (from Border Street to Dewey Street) as part of future projects.

WHEREAS, the City plans to improve ADA accessibility at City Hall as part of future projects.

WHEREAS, the City has also received grant funding to add sidewalks on Riggin Road north of Zenk Road, to add a shared-use path along the north side of US 40 from Main Street to CA Henning Elementary School, and to add a shared-use path along Wynona Street to West Clay Street.

**WHEREAS**, the City plans to apply for grant funding to add a shared-use path on Bouse Road from Old Troy Road to Whitworth Drive.

**WHEREAS**, the City plans to continue discussion with the Illinois Department of Transportation (IDOT) to improve sidewalks on Center Street, which is an IDOT owned and maintained facility within the City.

### NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TROY, ILLINOIS, AS FOLLOWS:

- 1. The recitals set forth above are hereby incorporated herein as if fully set forth.
- 2. The City of Troy, Illinois hereby continues to support the Americans with Disabilities Transition Plan prepared by Oates Associates, Inc. adopted by the City on June 20, 2016, a copy of which is attached hereto and incorporated herein as Exhibit A.
- 3. This Resolution shall be in effect following its passage, approval and publication as provided by law.
