RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A MEMORANDUM OF UNDERSTANDING TO EXTEND THE EXISTING AGREEMENT BETWEEN THE CITY OF TROY AND THE INTERNATIONAL ASSOCIATION OF MACHINISTS AND AEROSPACE WORKERS

WHEREAS, the City of Troy, Illinois, and the International Association of Machinists and Aerospace Workers are parties to a public works collective bargaining agreement currently in effect, with a term that expires on March 31, 2024; and

WHEREAS, the City and the Union both agree to extend the term of the current agreement up to and through April 30, 2024, under the same terms and conditions existing in the current agreement

NOW, THEREFORE, BE IT RESOLVED that the City Administrator be authorized to sign a Memorandum of Understanding with the International Association of Machinists and Aerospace Workers, extending said agreement by 30 days, to April 30, 2024.

PASSED by the City Council of the City of Troy, Madison County, Illinois, approved by the Mayor, and deposited in the office of the City Clerk this 18th day of March 2024.


WHEREAS, the City and the Union shall do all things necessary to execute and effectuate this Memorandum of Understanding; and

This Memorandum of Understanding is signed this 5th day of March, 2024.


