THE VILLAGE OF WAPELLA ORDINANCE NO. 2024-10-1675

AN ORDINANCE AUTHORIZATING APPOINTMENT OF VILLAGE CLERK

WHEREAS, the Village of Wapella has authority, pursuant to the Illinois Municipal Code (65 ILCS 5/3.1-25-90) by not less than two-thirds (2/3) of the Village Board to authorize the appointment of the Village Clerk, by the President, with a concurrence of the Village Board; and

WHEREAS, the Village of Wapella currently elects its Village Clerk; and

WHEREAS, it is in the best interest of the health, safety and welfare of the citizens of Wapella to authorize the Village President to appoint a Village Clerk rather than have a Village Clerk elected.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees for the Village of Wapella, DeWitt County, Illinois, as follows:

SECTION 1: In accordance with the laws of the State of Illinois, the Village of Wapella does hereby choose to have the Village Clerk appointed by the Village President, with the concurrence of the Village Board.

SECTION 2: That effective May 1, 2025, the Village Clerk shall no longer be elected, but rather appointed by the President, with the concurrence of the Village Board, in conformity with the Illinois Municipal Code (65 ILCS 5/3.1-25-90).

SECTION 3. <u>Severability.</u> If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 4. Publication. The Village Clerk be and is hereby authorized and directed

to publish this Ordinance in pamphlet form as provided by law.

SECTION 5. Repealer. All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the Village of Wapella, prior to the effective date of this Ordinance.

SECTION 6. Effective Date. This Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
