

AN ORDINANCE OF THE BOROUGH OF YOE REGULATING MOTOR  
VEHCILES GENERALLY AND RESTRICTING VEHICLE LOADS BY  
WEIGHT ON CERTAIN STREETS LOCATED WITHIN THE BOROUGH

ORDINANCE NO. 2007 - 01

**WHEREAS**, the Borough Council of the Borough of Yoe, York County, Pennsylvania, is charged with the duty of protecting the general health, safety, and welfare of the Citizens of Yoe Borough; and

**WHEREAS**, the Borough Council of the Borough of Yoe is desirous of promoting safe passage of motor vehicles upon the roadways of Yoe Borough; and

**WHEREAS**, the Borough Council of the Borough of Yoe has concluded that travel by motor vehicles weighing in excess of 9,001 pounds would constitute a risk and danger on certain streets located within the Borough due to narrowness and design of said streets; and

**WHEREAS**, the Borough Council of Yoe Borough has sought the review and comment of the York County Planning Commission Transportation and Engineering Services Division; and

**WHEREAS**, a study has been provided to the Borough confirming that street restrictions should be imposed on certain Borough Streets.

**NOW THEREFORE, BE IT ENACTED AND ORDAINED, AND IT IS HEREBY ENACTED AND ORDAINED AS FOLLOWS:**

**Section 1.** Vehicle Weight Limits Established on Certain Streets and Bridges.

By authority granted pursuant to the terms of the Pennsylvania Motor Vehicle Code, it shall be unlawful for any person or persons to drive any vehicle or combination of vehicles having a gross weight in excess of 9,001 on the following designated roadways:

North Maple Street	Beginning at George Street and terminating at Yoe Drive	9,001

West High Street	Beginning at Main Street and terminating at North Maple Street	9,001
pounds		
East High Street	Commencing at Main Street and terminating at end of street	9,001
pounds		

**Section 2.** The Yoe Borough Council, its agents and/or assigns, are hereby authorized to erect in accordance with the provisions of the Pennsylvania Motor Vehicle Code, any and all appropriate signs designating the aforementioned roadways as streets having restricted weight limits.

**Section 3.** Any person who violates any provisions of this Ordinance shall be prosecuted under the appropriate provisions of the Motor Vehicle Code and upon conviction shall be sentenced to pay a fine of \$150.00 for each 500 pounds or part thereof in excess of 3,000 pounds over the maximum allowable weight together with cost of suit.

**Section 4.** This Ordinance shall take effect immediately upon its passage.
