

AN ORDINANCE OF THE BOROUGH OF YOE, YORK COUNTY,
PENNSYLVANIA, AUTHORIZING THE BOROUGH OF YOE TO ENTER
INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT WITH
RED LION BOROUGH TO PROVIDE ZONING OFFICER SERVICES TO YOE
BOROUGH; PROVIDING A SEVERABILITY CLAUSE;
AND PROVIDING AN EFFECTIVE DATE

ORDINANCE NO. 2007 - 05

WHEREAS, the Borough Council of the Borough of Yoe, York County, Pennsylvania,
is charged with the duty of protecting the general health, safety, and welfare of the Citizens of
Yoe Borough; and

BE IT ENACTED AND ORDAINED by the Council of the Borough of Yoe, and it is
hereby enacted and ordained as follows:

**AGREEMENT TO PURCHASE ZONING
SERVICES FROM RED LION BOROUGH**

SECTION I.

1. Articles.

Yoe Borough hereby approves entering into an Intergovernmental
Cooperation Agreement (hereinafter referred to as "Agreement") to purchase zoning officer
services from Red Lion Borough in accordance with the terms and conditions as may be agreed
to by the respective Boroughs.

2. Authorization; Execution.

Yoe Borough is authorized to enter into the Agreement for the purposes
contained therein, and the President or Vice-President of the Borough Council, acting alone or
together with the Secretary or Assistant Secretary, are hereby authorized and directed on behalf
of Yoe Borough to execute said Agreement on behalf of the Borough, and to execute and deliver
any additional instruments, and to take such further actions, as may be necessary or appropriate
to carry forth the Agreement and the transaction to be effected under the Agreement.

3. Intergovernmental Agreement.

As required by the Intergovernmental Cooperation Act, the following matters are hereby set forth:

A. The conditions of the Agreement are set forth in the Articles of Agreement to be agreed upon by the parties.

B. Yoe Borough shall participate in the Agreement and provide zoning officer services to Yoe Borough for an initial term of six months, with renewal and extension of the terms of the Agreement permitted as provided therein.

C. The purposes and objectives of the Agreement are to provide zoning services for Yoe Borough.

D. The manner and extent of financing the Agreement are that (i) no borrowing will be required by Red Lion Borough, (ii) funds to implement Red Lion Borough's obligations under the Agreement shall come from normal and usual budgeted amounts for such matters, and Red Lion Borough shall charge Yoe Borough for the services rendered at a price to be agreed upon in the Agreement.

SECTION II.

The provisions of this Ordinance are severable and if any section, sentence, clause or part or provision hereof shall be held to be illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect the remaining sections, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough of Red Lion that such Ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION III.

Nothing contained in this Ordinance shall be construed to affect any suit or proceeding in any Court, or any rights acquired or liability incurred, or any cause or action existing prior to the enactment of this Ordinance.


SECTION IV.

This Ordinance shall become effective immediately upon enactment and approval.


