**ORDINANCE NO. 2018 - 01**

---

**AN ORDINANCE MODIFYING THE COMPENSATION FOR THE TAX  
COLLECTOR FOR YOE BOROUGH**

**WHEREAS**, the Yoe Borough Council has the duty under the Borough Code 8 Pa.C.S.A. §1006(6), “[t]o fix the compensation of all of the borough officers, appointees and employees”; and

**WHEREAS**, the Borough of Yoe (hereinafter “Borough”), in accordance with the provisions of the Local Tax Collection Law (72 P.S. §5511 *et seq.*), specifically Title 72, Chapter 4 §5511.35, had previously established the compensation rate for the position of the Tax Collector of Yoe Borough in its Borough of Yoe Code of Ordinances at Chapter 1, Part 5, Section 1 (§1-501); and

**WHEREAS**, the Yoe Borough Council desires to control cost expenditures and bring consistency and uniformity to the amount of compensation paid to any person (either elected or appointed) who performs the duties of Tax Collector for Yoe Borough; and

**WHEREAS**, the Yoe Borough Council has expressed its desire to modify the compensation paid to the Tax Collector for Yoe Borough, and make that amount of compensation consistent with the amount charged by the Treasurer for the County of York for the performance of the duties of the Tax Collector for Yoe Borough.

**NOW THEREFORE**, be it ENACTED and ORDAINED, by the Borough of Yoe, York County, Pennsylvania that Chapter 1, Part 5, Section 1 of the Code of Ordinances for the Borough of Yoe is hereby amended to read as follows:

**Part 5  
Tax Collector**

**§ 1-501. Compensation.**

1. The compensation rate for the Yoe Borough Tax Collector is ~~shall hereby fixed at rate of 3 percent of the amount collected of real estate taxes~~ be a salaried amount equal to the average of the annual fees charged by the York County Treasurer to Yoe Borough over the past 3 years, or, if the York County Treasurer has performed said services for less than 3 years, then compensation for the Tax Collector shall be a salaried amount equal to the fee charged by that Treasurer for performing the duties of the Tax Collector for the Borough in the immediately preceding year.

2. The effective date of this Section shall be effective immediately upon passage for any subsequent, specially elected or appointed Tax Collector.


3. The effective date of this Section for any duly elected Tax Collector shall be January 1, 2018 2022.

4. This Section shall not affect any other fees, ~~or~~ compensation, or reimbursement(s) the Tax Collector is able to receive by through existing laws or ordinances.
