**ORDINANCE NO. 2018 - 04**

**AN ORDINANCE AMENDING CHAPTER 15, PART 4, §15-401 AND EXPANDING  
THE NO PARKING ZONE ON THE EAST SIDE OF ELM STREET, NORTH OF THE  
SOUTH ELM STREET/ WEST PHILADELPHIA STREET INTERSECTION, IN YOE  
BOROUGH**

**WHEREAS**, the Yoe Borough Council had previously adopted Ordinance 2013-01, which, in part, prohibited parking at all times along the east side of South Elm Street for 60 feet North from the intersection of South Elm Street and West Philadelphia Street; and

**WHEREAS**, the Yoe Borough Council desires to better control traffic through the Borough by changing the traffic pattern at the intersection of South Elm Street and West Philadelphia Street by installing a stop sign at the end of West Philadelphia Street and removing two (2) stop signs currently on Elm Street at that intersection; and

**WHEREAS**, the Yoe Borough Council has determined that the expansion of the prohibited parking along the East side of South Elm Street, from 60 feet to 100 feet North of the intersection of South Elm and West Philadelphia Street is necessary to meet Sight Line requirements prescribed by the Pennsylvania Department of Transportation and promote safety to those traveling through the Borough;

**NOW THEREFORE**, be it ENACTED and ORDAINED, by the Borough of Yoe, York County, Pennsylvania that Chapter 15, Part 4, Section 1 (§15-401) of the Code of Ordinances for the Borough of Yoe is hereby amended to read as follows:

**Part 4**  
**General Parking Regulations**

**§15-401. Parking Prohibited at All Times in Certain Locations.**

Parking shall be prohibited at all times in the following locations:

N. Main St.	West	Northern Borough line to W. Pennsylvania Avenue (no parking here to corner)

S. Elm St.	West	Intersection of W. Philadelphia St. to intersection of W. Walnut St.
S. Elm St.	East	40 feet from intersection of S. Elm St. and Third St. to intersection

W. Philadelphia St.	South	Intersection of S. Elm St. to S. Fern Ave.
W. Walnut St.	North	S. Maple St. East 250 feet
