**AN ORDINANCE OF THE BOROUGH OF YOE, YORK COUNTY, PENNSYLVANIA,  
AMENDING CHAPTER 1, PART 2, SUBPART A, §1-201 THROUGH §1-204 OF THE  
YOE BOROUGH CODE OF ORDINANCES**

**WHEREAS**, an ordinance was adopted by the Borough of Yoe on December 13, 2005, and codified as Chapter 1 (Administration and Government), Part 2 (Borough Officials), Sub-Part A (Compensation), §1-201 (Salary of Mayor), §1-202 (Salary of the President of Borough Council), §1-203 (Salary of Vice-President of Borough Council), and §1-204 (Salary of Members of Borough Council); and

**WHEREAS**, the Yoe Borough Council believes it to be in the public interest to amend Chapter 1, Part 2 to bring that part up to date based on changing economic conditions since 2005.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED**, by the Borough Council of the Borough of Yoe, York County, Pennsylvania, and it is hereby ordained and enacted, in lawful session assembled, that Chapter 1, Part 2, Sub-Part A, §1-201, §1-202, §1-203, and §1-204 of the Yoe Borough Code of Ordinances shall be amended as follows:

**A. Compensation**

**§1-201. Salary of Mayor.**

The salary of the Mayor of the Borough of Yoe, York County, Pennsylvania, shall be fixed at ~~\$200~~ \$125 per month.

**§1-202. Salary of the President of Borough Council.**

The salary of the President of Borough Council of the Borough of Yoe, York County, Pennsylvania, shall be fixed at ~~\$200~~ \$125 per month.

**§1-203. Salary of Vice-President of Borough Council**

The salary of the Vice-President of the Borough Council of the Borough of Yoe, York County, Pennsylvania, shall be fixed at \$150 ~~\$100~~ per month.


**§1-204. Salary of Members of Borough Council**


The salary of members of Borough Council of the Borough of Yoe, York County, Pennsylvania, shall be fixed at \$125 ~~\$80~~ per month.


