

AN ORDINANCE EXTENDING AND LAYING OUT NORTH GEORGE STREET, OF THE BOROUGH OF YOE, FROM A POINT THREE HUNDRED AND FOURTEEN FEET ON SAID STREET, AS NOW LAID OUT, FROM THE CENTRE OF MAIN STREET, TO THE BOROUGH LINE; AND VACATING ALL THAT PORTION OF SAID NORTH GEORGE STREET, AS NOW LAID OUT, BEYOND A POINT THREE HUNDRED AND EIGHTY-ONE FEET FROM THE CENTRE OF SAID MAIN STREET.

SECTION 1. Be it enacted and ordained by the Chief Burgess and Town Council of the Borough of Yoe, and it is hereby enacted and ordained by authority of the same, that North George Street, in said borough, is hereby laid out, extended and adopted as a public street of said borough,

Beginning at a point on said street, as now laid out, three hundred and fourteen feet from the middle of Main Street, thence extending north, fifty-nine and one-half degrees; west, a distance of seventy-five feet of the width of thirty-five feet; thence, north, forty-three and one-fourth degrees; west a distance of one hundred and ninety-four feet to the middle of a street to be located and opened, of the width of thirty-eight feet, thence, north, forty-three and one-fourth degrees; west, for a distance of three hundred and sixty-three feet, of the width of thirty-eight feet, thence north, sixty-one degrees; west, for a distance of two hundred and fifty feet, of the width of thirty-eight feet; thence, north, forty-nine degrees, west for a distance of two hundred and seventy-seven feet, of the width of thirty-eight feet, to the borough line; subject to all the provisions and requirements of the paving ordinances of said borough, and also subject to all the provisions and requirements of all the other ordinances of said borough relating to the streets thereof.

SECTION 2. It is further enacted and ordained that the said North George Street as now laid out and used, beginning at a point three hundred and eighty-one feet distant from the centre of Main Street, and extending in a curve for a distance of four hundred feet, is hereby vacated.

EXTENDING BROAD STREET TO THE BOROUGH  
LINE IN THE BOROUGH OF YOE, YORK COUNTY,  
PENNSYLVANIA.

An Ordinance extending Broad Street to the Borough line. Be it enacted and ordained by the Chief Burgess and Town Council of the Borough of Yoe, and it is hereby enacted and ordained by the authority of the same.

That Broad Street be extended north forty degrees, west 587 feet to the Borough line, said street to be of a uniform width of 33 feet, with a sidewalk on each side of said street 6 feet wide, making the entire width of street and sidewalks 45 feet.
