AN ORDINANCE

AN ORDINANCE OF THE BOROUGH OF YOE, YORK COUNTY, PENNSYLVANIA, CREATING AND ORGANIZING AN AUTHORITY UNDER THE "MUNICIPAL AUTHORITIES ACT OF 1945," KNOWN AS PUBLIC LAW NO. 382, APPROVED MAY 2, 1945, TOGETHER WITH ALL SUPPLEMENTS THEREOF AND AMENDMENTS THERETO; FOR THE PURPOSE OF CONSTRUCTING OR OTHERWISE PROVIDING THE FACILITIES NECESSARY TO FURNISH SEWAGE TREATMENT FOR THE BOROUGH OF YOE AND SETTING FORTH IN FULL THE PROPOSED ARTICLES OF INCORPORATION AND OTHER MATTERS PERTAINING TO THE CREATING OF SAID AUTHORITY.

BE IT ENACTED by the Council of the Borough of Yoe, York County, Pennsylvania, and it is hereby ordained and enacted by the Authority of the same, as follows:

SECTION 1: It is the desire and intention of the municipal authority of the Borough of Yoe, York County, Pennsylvania, to organize a Sewer Authority under the "Municipal Authorities Act of 1945," designated as Public Law No. 382, approved May 2, 1945, together with all supplements thereof, and amendments thereto, for the purpose of exercising and enjoying all the powers of the Act, its Supplements and Amendments.

SECTION 2: The name of the proposed Authority is:
The Yoe Borough Sewer Authority.

SECTION 3: The proposed Articles of Incorporation of the Authority are attached hereto, made a part hereof, designated as Exhibit "A".

SECTION 4: The Authority shall consist of five persons, and the following named persons are hereby appointed members of the Board of the Authority.

1. Fred G. Vail of 349 S. Wilson Court, Yoe, Pennsylvania, whose term will expire, the 7th day of March, 1977.
2. Clarence E. Ludwig, of 81 E. Pa. Avenue, Yoe, Pennsylvania, whose term will expire the 7th day of March, 1976.
3. Wayne Kreidler of 93 E. High St., Yoe, Pennsylvania, whose term will expire the 7th day of March, 1975.

4. Stewart Rohrbaugh of 210 S. Main St., Yoe, Pennsylvania, whose term will expire the 7th day of March, 1974.

5. Charles G. Landis, Jr., of 134 S. Maple St., Yoe, Pennsylvania, whose term will expire the 7th day of March, 1973.

SECTION 5: The Articles of Incorporation of the Authority, in substantially the form set forth in Section 3, Exhibit "A", of this Ordinance, which shall be executed on behalf of the Borough of Yoe by the President of Borough Council and the Mayor of the Borough of Yoe, attested by the Secretary of the Borough of Yoe, and such officers are hereby authorized, empowered and directed to do all things necessary and appropriate to effect and establish the said Authority in conformity with the "Municipal Authorities Act of 1945," its supplements and amendments.

SECTION 6: The adoption of this Ordinance is deemed necessary for the benefit and preservation of the public health, peace, comfort and general welfare, and will increase the prosperity of the people of the Borough of Yoe, York County, Pennsylvania.

SECTION 7: That this ordinance shall become effective the 7th day of March, 1972.
