ORDINANCE NO. 81-001

AN ORDINANCE

ADOPTING AND APPROVING AN AMENDMENT TO THE ARTICLES OF INCORPORATION OF DALLASTOWN-YOE WATER AUTHORITY, AS PROPOSED BY RESOLUTION OF THE BOARD OF SAID AUTHORITY; SETTING FORTH THE PROPOSED AMENDMENT; AUTHORIZING THE AUTHORITY AND PROPER OFFICERS THEREOF TO EXECUTE, VERIFY AND FILE APPROPRIATE ARTICLES OF AMENDMENT; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT THEREWITH.

VÆEREAS, Dallastown-Yoe Water Authority (the "Authority"), is a municipality authority, incorporated and existing under the Pennsylvania Municipality Authorities Act of 1945, approved May 2, 1945, P. L. 382, as amended and supplemented (the "Authorities Act"), pursuant to Ordinances of the respective Councils of the Borough of Yoe and the Borough of Dallastown, both of York County, Pennsylvania (the "Boroughs" ) ; and

WHEREAS, The Authority, by resolution duly adopted, has proposed that its Articles of Incorporation shall be amended so as to increase its term of existence, which amendment is authorized and permitted by the Authorities Act; and

REAS, The Authority has caused to be submitted to the Council of this Borough a copy of the resolution adopted by the Board of the Authority, duly certified by the Secretary of the Authority, wherein said amendment is proposed, which resolution contains the language of said proposed amendment; and

VÆEREAS, The Authorities Act provides, inter alia, that the Council of this Borough and Council of the Borough of Dallastown, being the governing authorities of the municipalities composing the Authority, shall adopt or reject said proposed amendment by resolution or ordinance.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Council of this Borough, as follows :

Section 1 . The Council of this Borough adopts and approves the amendment to the Articles of Incorporation of the Authority, as proposed by a resolution duly adopted by the Board of the Authority, a copy of which resolution, duly certified by the Secretary of the Authority, has been submitted to the Council of this Borough.

Section 2 . The amendment to the Articles of Incorporation of the Authority, which is adopted and approved, shall add paragraph 8 to the Articles of Incorporation which shall read as follows :

"8. The term of existence of said  
Dallastown-Yoe Water Authority shall be for a period  
ending January 31, 2031."
