ORDINANCE PRESCRIBING SPEED LIMITS ON THE STREETS
IN THE BOROUGH OF YOE, YORK COUNTY, PENNSYLVANIA

Be it enacted and ordained by the Board of Yoe Borough Council, York County, Pennsylvania as it is hereby enacted and ordained as follows:

1. The speed limit of 25 miles per hour is hereby established on the following streets, to wit:

North and South Main Street, from the North Borough line to the South Borough line, East and West George Street, from the East Borough line to the West Borough line, West High Street, from North Maple Street to North Main Street, East High Street from North Main Street to North Boundary Avenue, North and South Boundary Avenue, from East Philadelphia Street to East George Street, North Maple Street, from West George Street to the Borough line; South Maple Street, from West Station Avenue to West Walnut Street; East Water Street, from North Main Street to Church Street; West Water Street, from North Main Street to Borough line; North Mason Avenue, from Pennsylvania Avenue to West George Street; South Mason Avenue, from Pennsylvania Avenue to West Walnut Street; Station Avenue, from South Main Street to Borough line; East Pennsylvania Avenue, from Church Street to North Boundary Avenue; West Pennsylvania Avenue, from North Main Street to North Maple Street; South Orchard Street, from West Broad Street to Southwest Borough line; West Walnut Street, from Newton Avenue to West Borough line; West Broad Street, from South Main Street to West Borough line; South Elm Street, from Newton Avenue to South Borough line; Wilson Court from East Philadelphia Street to East Fourth Street; East Philadelphia Street, from South Main Street to East Borough line; West Philadelphia Street, from South Main Street to South Elm Street; East Third Street, from South Main Street to East Borough line; West Third Street, from South Main Street to West Borough line; East Fourth Street, from South Main Street to East Borough line;

West Fourth Street, from South Main Street to Southwest Borough line.

SECTION 2.

This Ordinance shall become effective immediately upon passage.
