ORDINANCE

AN ORDINANCE ESTABLISHING AND CONFIRMING THE PLACEMENT OF STOP SIGNS ON PUBLIC STREETS WITHIN THE BOROUGH OF YOE.

BE IT ENACTED AND ORDAINED by the Borough of Yoe Council, York County, Pennsylvania, and it is hereby enacted and ordained as follows:

SECTION I

It shall be lawful for the placement of stop signs at the following intersections and all others later approved by resolution of Council:

Maple Street at the intersection of Yoe Drive  
 West High Street at the intersection of Maple Street  
 Maple Street at the intersection of West George Street  
 West George Street at the intersection of North Main Street  
 East George Street at the intersection of North Main Street  
 Mason at the intersection of Water Street  
 West Pennsylvania Avenue at the intersection of North Main Street  
 Street  
 Water Street at the intersection of North Main Street  
 Broad Street at the intersection of South Main Street  
 West High Street at the intersection of North Main Street  
 East High Street at the intersection of North Main Street  
 East Water at the intersection of Church Street  
 North Boundary Avenue at the intersection of East George Street  
 Street  
 East George Street at the intersection of Church Street  
 West Broad Street at the intersection of South Poplar  
 South Orchard Street at the intersection of West Walnut  
 South Maple Street at the intersection of West Walnut Street  
 South Elm Street at the intersection of West Philadelphia Street  
 Street  
 West Third Street at the intersection of South Elm Street  
 West Fourth Street at the intersection of South Elm Street  
 West Fourth Street at the intersection of South Main Street  
 East Fourth Street at the intersection of South Main Street  
 West Third Street at the intersection of South Main Street  
 East Third Street at the intersection of South Main Street  
 West Philadelphia Street at the intersection of South Main Street  
 Street

East Philadelphia Street at the intersection of South Main Street

SECTION II

The signs and their placement shall comply with all pertinent Pennsylvania Department of Transportation regulations.

SECTION III

This Ordinance shall become effective immediately upon its passage.
