DATED: July 7, 1987

WHEREAS, the use of skateboards on the public streets and on sidewalks within the Borough of Yoe is a danger to the skateboard user, pedestrians, and motorists;

WHEREAS, the use of sleds, toboggans, saucers or similar recreational equipment for gliding or sliding on ice or snow is no longer safe on public streets within the Borough because of increased traffic congestion.

ORDINANCE

AN ORDINANCE PROHIBITING THE USE OF SKATEBOARDS ON PUBLIC STREETS AND ON SIDEWALKS WITHIN THE BOROUGH OF YOE AND THE USE OF SLEDS, TOBOGGANS, SAUCERS OR SIMILAR RECREATION EQUIPMENT ON THE STREETS OF THE BOROUGH.

BE IT ENACTED AND ORDAINED by the Borough of Yoe Council, York County, Pennsylvania, and it is hereby enacted and ordained as follows:

SECTION I

The use of skateboards on all public streets and on all sidewalks adjacent to public streets is hereby forbidden.

SECTION II

The use of sleds, toboggans, saucers or similar recreational equipment for gliding, coasting or sledding on ice or snow is hereby forbidden on public streets within the Borough of Yoe. The Borough reserves the right to designate a street or portion thereof for sledding, coasting or similar use. Such designation shall be made by the Mayor and shall expire at 4:00 P.M. on the day designated.

SECTION III

Any person violating the provisions of this Ordinance shall be subject to summary criminal proceedings under this section and shall be sentenced to pay a fine not to exceed \$300.00. Summary criminal prosecution under this Ordinance may be commenced by the appropriate police department or by the Mayor.

SECTION IV

This Ordinance shall be effective ten days after its passage.
