**RESOLUTION OF BOROUGH COUNCIL OF THE BOROUGH OF YOE
AUTHORIZING BOROUGH COUNCIL TO ESTABLISH FEES**

WHEREAS, the Borough Council of the Borough of Yoe has adopted a consolidation and revision of the ordinances of the Borough of Yoe; and,

WHEREAS, it is the desire of the Borough Council of the Borough of Yoe to eliminate all filing fees, permit fees and license fees from the Code of Ordinances and has enacted them instead by resolution and has set a "Fee Schedule" which can be changed from time to time by resolution; and,

NOW, THEREFORE BE IT RESOLVED THAT and it is hereby resolved by the Borough Council of the Borough of Yoe that all fees within the Fee Schedule are hereby fixed as follows:

PARKS AND RECREATION

Park rental for activities proposed -\$150

PROPERTY MAINTENANCE CODE

Fees for the licensing and inspection of rental units and appeals,

Missed inspection appointment fee -\$50

UNIFORM CONSTRUCTION CODE

All Applicants for Building Construction Permits, which require third party plan reviews, shall be responsible for all Third Party plan review costs as set forth, plus a 5% surcharge of the total project cost, payable to the Borough.

Residential Construction Fee Schedule**

CAI shall conduct all services according to the following fee schedule being paid to CAI based on the monthly services utilized or upon the issuance of the building permit, as the Municipality policy shall dictate. All re-inspection billing shall be conducted by CAI and no final Certificate of Use and Occupancy can be obtained until such time as all fees are paid. No building permit or Certificate of Use and Occupancy shall be deemed approved without payment of fees.

Notice of Violation, court filings and appearance \$75 per hour

construction inspection -\$60 per inspection.
plans review fee per dwelling unit - \$200
re-inspections -\$60 per trip to job site
Fire sprinkler systems \$40 per hour

Residential Zoning & Property Maintenance

Zoning Permit- to include review and one site inspection \$65.00 per permit \$30 re-review fee.
Zoning appeals-\$40 per ½ hour
Initial Complaint -\$45 per dwelling unit
Abatement Inspections - \$30 per dwelling unit
Notice of Violation – \$55 per dwelling unit each occurrence
Court filings- for summary offense -\$75 per hour
Processing and posting unsafe structures - \$55 per dwelling unit each occurrence related services not identified – billed at \$75 per hour
Rental Inspections, tri-annual & corrective inspections \$35 per hour
Emergency Response Services are conducted at \$150 per hour

Commercial Fee Schedule

(New Construction, Additions and Alterations)

CAI shall conduct all services according to the following fee schedule being paid to CAI based on the monthly services utilized or upon the issuance of the building permit, as the Municipality policy shall dictate. All re-inspection billing shall be conducted by CAI and no final Certificate of Use and Occupancy can be obtained until such time as all fees are paid.
