**ORDINANCE NO. 2012- 18**

**AN ORDINANCE AMENDING TITLE III, CHAPTER 32, SECTION 51 –  
COMPENSATION (CITY CLERK) - OF THE CODE OF ORDINANCES FOR  
THE CITY OF TROY, ILLINOIS**

**WHEREAS**, the Code of Ordinances of the City of Troy, Illinois sets forth the compensation of elected officials; and

**WHEREAS**, the City Council of the City of Troy, Illinois, has determined it is in the best interests of the City to adjust the compensation of elected officials, including but not limited to the City Clerk, to adequately compensate the elected officials for the time and efforts of those elected individuals, and to attract and encourage dedicated individuals to seek public service; and

**WHEREAS**, the City Council of the City of Troy, Illinois, has reviewed the compensation of elected officials, including but not limited to the City Clerks of surrounding communities and the review revealed that it is necessary to adjust the compensation to make the City of Troy competitive with the compensation offered other elected officials in surrounding communities; and

**WHEREAS**, the City Council of the City of Troy, Illinois, wishes to adjust the compensation of elected officials in accordance with 65 ILCS 5/3.1-50-10 and 15; and

**WHEREAS**, Title III, Chapter 32, Section 51, sets forth the compensation for the City Clerk, and is hereby amended in its entirety; and

**WHEREAS**, the compensation of the City Clerk as changed pursuant to this Ordinance shall become effective at such time as mandated by the laws of the State of Illinois, 65 ILCS 5/3.1-50-10 and 15, and shall become effective for terms of elected officials beginning on May 1, 2013.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF  
THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:**

- Section 1. The recitals set forth above are hereby incorporated herein as if fully set forth.
- Section 2. Section 32.051 – COMPENSATION (City Clerk) - of the Code of Ordinances for the City of Troy, Illinois, is hereby amended in its entirety as set forth herein:

TITLE III. Administration

Chapter 32 – OFFICERS, EMPLOYEES AND OTHER WORKERS

Section 35.051 – COMPENSATION (City Clerk)

- (A) The City Clerk shall receive as his or her compensation for the performance of his or her duties the amount of \$36,000.00 annually for the twelve (12) month period beginning May 1, 2013 through April 30, 2014. Thereafter, the compensation paid to the City Clerk for the performance of his or her duties shall increase in three (3) consecutive annual increments of two and one-half percent (2.5%) based upon the base salary existing at the time of each increase. The three (3) consecutive increases shall be applicable for the periods of May 1, 2014 through April 30, 2015; May 1, 2015 through April 30, 2016; and May 1, 2016 through April 30, 2017. The City Clerk shall be eligible to participate in the City's health insurance coverage plan with the same terms and conditions offered to all other non-bargaining unit employees of the City.
- (B) If the City Clerk makes an election to participate in the Illinois Municipal Retirement Fund, which the City Clerk is entitled to make pursuant to § 7-137 of the Illinois Pension Code, the City Clerk's total salary in each of the four successive one-year periods, beginning on May 1, 2013, shall be the City Clerk's basic salary specified in Section (A) herein, plus whatever contribution the City is required by law to make to the Illinois Municipal Retirement Fund for the City Clerk.
- (C) The City Clerk's basic salary shall be paid to the City Clerk in twenty-six (26) equal bi-weekly installments.

Section 3: If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 4: All Ordinances, Resolutions, Motions and Orders that conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 5: This Ordinance shall be effective upon its passage, signing and publication as required by law.


