ORDINANCE NO. 2012 - 20

AN ORDINANCE AMENDING TITLE VII, TRAFFIC CODE, CHAPTER 72, SECTION 23 AND CHAPTER 74, SCHEDULE II, TO ADD AND ESTABLISH CERTAIN PARKING RESTRICTIONS ON THE EAST SIDE OF NORTH HICKORY STREET FROM EAST MARKET STREET TO EAST CLAY STREET

WHEREAS, the City of Troy, Madison County, Illinois, has heretofore established certain no parking zones and parking restrictions to promote pedestrian and vehicular safety on the streets and thoroughfares of the City of Troy; and

WHEREAS, based on a review conducted by the City of Troy, the City has determined that the creation of additional parking restrictions will further enhance pedestrian and vehicular safety within the corporate limits of the City of Troy; and

WHEREAS, the City of Troy believes it is in the best interests of the City and its citizens to establish certain parking restrictions on the East side of North Hickory Street from East Market Street to East Clay Street.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY, MADISON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. That the City Council hereby determines that the preambles hereto are true and correct and are incorporated herein by reference as if fully set forth herein.

Section 2. Chapter 72, Section 23 and Chapter 74, Schedule II of the Code of Ordinances of the City of Troy are hereby amended by adding and establishing the following parking restrictions to be in effect on the East side of North Hickory Street from East Market Street to East Clay Street.

- (a) It shall be unlawful for any person to park or stand any vehicle on the East side of North Hickory Street from East Market Street to East Clay Street.

Section 3. Any violation of this Section shall be punishable by a fine of not less than Twenty-five Dollars (\$25.00) and not more than Five Hundred Dollars (\$500.00).

Section 4. The foregoing restrictions shall be set forth on parking signs conforming to the Illinois Department of Transportation's Sign Manual and Specifications. The location of these signs shall

conform to the same requirements of the Illinois Department of Transportation's Sign Manual and Specifications.

Section 5. If any section or provision of this Ordinance is declared invalid for any reason, such invalidity shall not affect or impair any of the remaining sections or provisions of this Ordinance which can be given effect without the invalid section or provision, and to this end, the sections and provisions of this Ordinance are declared to be severable.

Section 6. This Ordinance shall be effective upon its passage, signing and publication as required by law.




